2020 Human Trafficking Symposium & MMIW Awareness

On February 29, 2020, the Flathead Valley Community College student group, Native American Student Association (NASA), co-sponsored with the Montana Human Rights Network/Love Lives Here, a free to the public, day-long informational symposium and training around the fight against Human Trafficking in Montana. Special emphasis was placed on Missing and Murdered Indigenous Women (MMIW). A training followed the symposium. The training raised awareness of human trafficking nationwide and locally, as well as what is being done locally to combat trafficking. One goal was to help participants be equipped with knowledge to help the average person recognize red flags, warning signs, and steps to take when you suspect or encounter a victim. This event helped to build on the MMIW event last year that was co-hosted by the Montana American Indian Scholars Program (MAIS) and Love Lives Here.

Symposium/Training Agenda

Bullock in 2017
- Representative from the Flathead County Sheriff's Office
- Chief Overman from the Kalispell Police Department
- Representatives from DeliverFund

Training was provided by the Lifeguard Group – a non-profit group from Missoula that works in collaboration with Law Enforcement Agencies and communities to fight human trafficking and support restoration for victims.

Impact

Providing cultural and educational opportunities for the campus and greater community is a part of the MAIS Program mission. Approximately 80 were in attendance. The audience was made up of students, college staff, community members (including a number of teachers and health care professionals) and those who traveled from out of the area. Certificates for CEU's were available for behavioral health professionals. This event helped participants learn about issues impacting tribal communities and steps being taken to address missing persons and human trafficking.

2019 Indigenous Craft Fair

On December 7, 2019, the Montana American Indian Scholars Program (MAIS) co-sponsored, with Montana Human Rights Network/Love Lives Here, an Indigenous Craft Fair. Free to the public, this was an opportunity for Native American artisans to showcase and sell their arts and crafts (items such as beadwork, ribbon quilts, paintings and more). Artists and crafters from the Flathead and Blackfeet Reservations were invited.

Claire Charlo, member of Confederated Salish & Kootenai Tribe, inspired the idea and reached out to various artists and crafters. Love Lives Here helped Flathead Valley Community College promote the event, as well as provided refreshments for vendors and the public. MAIS Scholars (FVCC students) assisted during the event and helped build awareness of the MAIS Program's efforts to support Native American students at FVCC. It was our first craft fair and although we had only 6 vendors, the community response was positive and the vendors described the event as successful. Approximately 150-200 community members visited. We plan to build on the success of our first Craft Fair once Covid-19 concerns abate.


Montana American Indian Scholars is a statewide initiative established by the Montana Office of the Commissioner of Higher Education to support American Indian students on Montana college campuses by promoting cultural awareness and creating leadership opportunities through mentoring. FVCC's Montana American Indian Scholars Program and Native American Student Association had worked hard during the 2019-20 academic year on plans for hosting the Similinekem (Meeting of the Rivers) Powwow and celebration of American Indian culture. This event was planned for Saturday, April 27, 2019, to be held on the FVCC campus. Covid-19 concerns and the mandatory stay-at-home order required the event to be postponed.

Planning is still in the works and will continue into the 2020-21 academic year, with the goal of holding the Powwow in late April or early May, 2021. The Powwow Committee includes FVCC students, staff, community members and members from the Blackfeet Tribe and Confederated Salish & Kootenai Tribe.

Free and open to the community, the event will feature dancing, drumming and storytelling by members of the Blackfeet, Confederated Salish & Kootenai, as well as other nations. Special emphasis will be placed on American Indian youth who are keeping cultural traditions alive. Co-host drums will be from Two-Eagle River High School, Ronan High School, Browning Middle School, and Heart Butte. The FVCC Simminekem Powwow will be promoted in the K-12 schools in the Flathead Valley and across the states of Montana, northern Idaho and Washington, as well as tribal colleges.
