Revised Operating Budgets - FY2013: Montana State University-Bozeman

THAT

The Board of Regents of Higher Education authorizes the amended fiscal year 2013 operating budget for Montana State University-Bozeman as submitted herein, increasing overall budget authority by \$3,200,000.

EXPLANATION

As noted during the September 2012 Board of Regents meeting, Montana State University-Bozeman expected to exceed the enrollment and tuition projections used in developing its FY13 Budget. The original revenue estimate was based on 12,782 FTE and the revised revenue estimate is based on 12,984 FTE; an increase of 202 FTE over the original projection.

The FY13 additional tuition revenue associated with this enrollment is estimated at \$3,200,000.

Montana State University is requesting a revision of previous budget authority in the amount of \$3,200,000.
