Whitefish is designated as a federal primary care Health Professional Shortage Area (HPSA). North Valley Hospital recruited for an internal medicine and pediatrics physician for over a year before securing the services of Dr. Austin. During the past five years, the area lost the services of 4 physicians practicing in pediatrics, family medicine, and internal medicine due to relocation and retirement. In addition, they expect to lose 3 more physicians in internal medicine, family medicine, and OB/GYN within 3-5 years due to additional retirements. There is a shortage of internal medicine/pediatrics providers in the service area; Dr. Austin is one of only two pediatricians practicing in the service area at the current time. Availability of loan repayment to assist with Dr. Austin's medical education loans would benefit the community with their efforts to retain her services.
