## Montana University System **Dual Enrollment Expansion Taskforce**

Progress Report to BOR February 14, 2014

The Dual Enrollment Workgroup was charged to propose concrete recommendations to facilitate the expansion of Dual Enrollment opportunities in the state of Montana. To date, deliberations have created six distinct recommendations which are currently being further refined with a goal to present policy proposals to the Board of Regents in May, 2014.

Recommendation #1: Convene a group to explore factors which will incentivize and motivate high school teachers who already have a Master's degree but need to earn up to nine graduate credits in the discipline with the goal of increasing concurrent enrollment courses offered by high school teachers in the high schools.

Next Steps: to be determined after Recommendations #2 through #6 are completed.

### Recommendation #2: Convene a group to review the Class 8 process to see how we can update, streamline, and make the process more efficient.

Workgroup: Terry Kendrick, Marco Ferro, Pete Donovan, Sue Jones, Kim Schrenk, Brenda Hanson, and Janice Alexander, and guest Elizabeth Keller, OPI Educator Licensure Manager

Progress: Deputy Commissioner Moisey met with the Board of Public Education CSPAC (Certification Standards and Practices Advisory Council) in February. Follow up efforts are underway to convene a meeting including representation from the Dual Credit Taskforce and a representation of two-year college Chief Academic Officers to discuss possible strategies for streamlining Class 8 approval process.

Recommendation #3: Create consistent standards in the Montana University System (MUS) regarding concurrent enrollment, in areas including but not limited to pay, assessment, textbooks, site visits, assessment/evaluations, and participation in campus orientations.

Workgroup: Amy Verlanic, Daniel Bingham, Heidi Pasek, Lynn Stocking, Dave Hall, Roch Turner, Curtis Biggs, Amy Williams, and Kristen Jones

Progress: The Taskforce convened on February 14 to review a draft of statewide guidelines for MUS college agreement with a high school to provide dual enrollment. The purpose of the guidelines is to establish a partnership that provides post-secondary opportunities for eligible high school students, specifically dual enrollment classes. Additionally, the purpose of the agreement is to define the procedures related to dual enrollment of high school students in college classes including: college's role, school district's role, and the students' role. The document also provides guidelines outlining faculty approval, student eligibility, program

coordination and quality, text books and materials coordination, college resources, and data collection and analysis. The Taskforce will present the statewide guidelines for MUS college agreement with a high school to the BOR for approval in May 2014.

# Recommendation #4: Convene a group to explore allowing the National Board Certification (NBC) within a disciplinary focus to be an alternative for the nine graduate credits in the subject area.

Workgroup: Marsha Riley, Pete Donovan, Amy Verlanic, Terry Kendrick, Marco Ferro, Dave Hall and John Cech

Progress: MSU Billings and City College set up a meeting in February with NBC teachers and college faculty to better understand Board Certification discuss the potential for allowing Board Certification to serve as an alternative for the nine graduate credits in the subject area. The subgroup will report out to the Taskforce at the next scheduled meeting with plans to form a recommendation related to factoring NBC into faculty approval process.

## Recommendation #5: Review the dual enrollment student application process and check for adherence to approved MUS standards.

Progress: Three recommendations: 1) Create consistent template for campuses to display dual enrollment courses on websites including: Dual Credit (campus based); Online Dual Credit; Concurrent Enrollment (high school based taught by high school teacher); and early college (college credit only); 2) Create Dual Enrollment Website via MUS.EDU which will provide electronic link to dual enrollment website of all public Montana colleges providing dual enrollment (complete for Fall 2014 – roll out in Summer 2014); 3) Pilot a college by Fall 2014 with electronic registration.

#### **Other Progress**

### **Expansion of Dual Enrollment Opportunities in Billings:**

Chancellor Rolf Groseth, Provost Mark Pagano, Dean Marsha Riley, and Deputy Commissioner John Cech have convened several meetings since late January including a broad list of stakeholders from MSU Billings, City College, Billings School District No. 2, and Billings Catholic Schools to discuss expansion of high school based dual enrollment in the Billings area. The goal of these meetings is to come to an agreement on a dual enrollment program with the first phase planned to begin with Fall 2014. Considerations for moving forward include:

 Success could be optimized by having college faculty work directly with high school faculty

- Strategize to provide classes that would help SD2 with completions
- Strategize to increase interest in HS to College matriculation (i.e. appeal to some of those students "on the margin")
- Look to appeal to students and parents as "An opportunity to reduce college debt"
- Provide course opportunities for students that may not be inclined to take AP coursework
- Focus on demographics that are less likely to matriculate to college
- Build on the success with existing *University Connections* initiative
- Consider providing a central point person to coordinate activities between the many offices involved on all sides (i.e. SD2, Local Billings High Schools, City College and the MSUB University Campus

#### **Performance-based Dual Enrollment Allocation**

Legislative OTO Funds Allocated Dual Enrollment Expansion; includes potential funding for all 2-year campuses and programs

#### Criteria

1) Performance pool established for each campus; total dual enrollment funding split over 3 semesters, between 12 campuses

- 2) Campuses will receive funds after each semester (Fall 2013, Spring 2014, and Fall 2014).
- 3) Funds must be used in support of increasing Dual Credit, preferably face to face instruction within a high school.
- 4) Campuses compete against themselves; awarded funds for increases above previous semester. (fall to fall, spring to spring)
- 5) Performance measures based on two metrics, weights are put on each metric to signify importance.
- 6) Campuses receive semester performance pool if weighted points increase and overall dual enrollment headcount grows by 10 or more.
- 7) Residual amounts (i.e. amounts not awarded) will be redistributed to campuses making progress.
