Proposed Budget Department of History

PhD students get higher stipends. The Graduate School will provide two PhD Teaching Assistantships which carry an annual stipend of 14,000.

2. Please evaluate library resources. Are they adequate for operation of the proposed program? If not, how will the library need to be strengthened during the next three years?

Library resources have expanded exponentially due to the world wide web. The Dartmouth College Library, for example, makes 70,000 journal articles available. Historians can always buy more books or subscribe to more serials. We anticipate strengthening the Mansfield Library's resources on a case-by-case basis with requests to the appropriate sources. A modest increase in the Library budget will automatically accrue, once this program is approved.

3. Please indicate special clinical, laboratory, and/or computer equipment that will be needed. List those pieces of equipment or computer hardware presently available in the department.

No additional clinical or laboratory equipment would be required. The program requires computer facilities for doctoral candidates. These may be reallocated computers as the University proceeds with its replacement program.

4. Please describe facilities and space required for the proposed program. Are current facilities adequate for the program? If not, how does the institution propose to provide new facilities?

Currently, space needs for faculty and staff are supplied within the departments involved. The department would over time require two additional offices to accommodate the slightly expanded number of graduate students.
