

We are a plumbing and heating contractor currently employing 21 journeyman and 7 apprentice plumbers. We are constantly recruiting young men and women to work for us. However, we find it very difficult to find people with sufficient knowledge and training in our field. If we had the ability to hire properly trained Montana kids, for our company, we would do so!
