Some of the campuses are more than double UM's fee for a full time student. This increase will support increasing needs for minor construction and renovation of campus facilities. |

(utilities, bad debt, credit card charges and assessment increases) The Student Health Advisory Committee recommended (CHS did not propose) a \$1 increase in the fee to cover services related to sexual violence prevention. |

| Acceptance Deposit Pharmacy, Physical Therapy, and Social Work | \$150 | \$300 | 100% | The Physical Therapy program has encountered difficulties enrolling replacement students and has absorbed additional administrative costs when students rescind their acceptance during the summer. A larger deposit may deter late withdrawals. It is applied to tuition when students enter the program. |
| Duplicate Diploma Fee | \$10 | \$30 | 33% | The fee set in 1996 no longer represents the costs of processing requests and creating validated copies of diplomas. The new fee will cover the current cost. |
| First Aid Lab Fee | \$6.50 /Semester | \$12 /Semester | 85% | The American Heart Association doubled their standard fee for certification and the Red Cross requires a site fee (\$500). |
| Physiology Lab Fee | \$10 /Semester | \$11 /Semester | 10% | The cost of expendables (gas, electrodes, pads) has increased by more than 10%. |

| Biological Station Field Course Fee | \$21 /Credit | \$30 /Credit | 43% | This fee will be necessary to cover the additional costs (transportation, field equipment) associated with our field-oriented courses that emphasize hands-on learning. Previously, two fees were approved for our courses – Field Course Fee (\$21/credit) and Equipment Fee (\$13/credit). These two fees have been combined into one fee and the amount requested is less per credit (\$30/credit). |
| Building Maintenance Engineering Course Materials Fee | \$10 | \$12 | 20% | Reflects the rising costs of wood, paint, nails, stain, glazing, glass, sheetrock, ceiling tile, paneling, and cabinets. These costs were re-assessed after a 5-year period. |

Increases in these fees are in accord with the increased costs of purchasing welding supplies that are consumed in the class welding rods, gas, iron, grinding wheels, grinding discs, electrodes, wire, and shielding gases). The fees were re-assessed after more than 5 years at previous rates. |
