## 14. Do you have any additional comments regarding the services that are available for students transferring to UM-Western?

Not So Positive

- I was very disappointed in the way my courses from Lethbridge Community College didn't transfer at all. The courses I took were very general and all general studies classes.
- When I applied, I was unaware of intentions of Western going to block schedule. If I would have known this before hand I would have chosen another school. I commute from Anaconda and the block schedule would be no benefit to me because I would have to drive there every day.
- I could have been walked through [the process] a little more to make things go easier.
- It is very hard to figure out when classes are offered. The catalog says one thing then the classes aren't offered when it says. Because of this reason, Linda Lucero really had my plan of study screwed up for a while. It wouldn't have worked out at all.
- Very difficult process. I have many problems that are not being answered. Most of the help was very hard to find and I was treated poorly by employees in student affairs offices
- The registrar's office needs to get on top of things. Was very disappointed with their organization.

• I tried on-line and it said I was registered. I found out later I was not. It was terrible and frustrating. I even had to call from a pay phone at a gas station in WI in 100 degree heat during a family vacation while my whole family waited in the car. Definitely not worth it. I hope you get the library degree program figured out. I don't want to ever take a class from Western again. I doubt as a teacher at a high school here in Billings I will ever advise anyone to go to Western. (Susan Vert)
